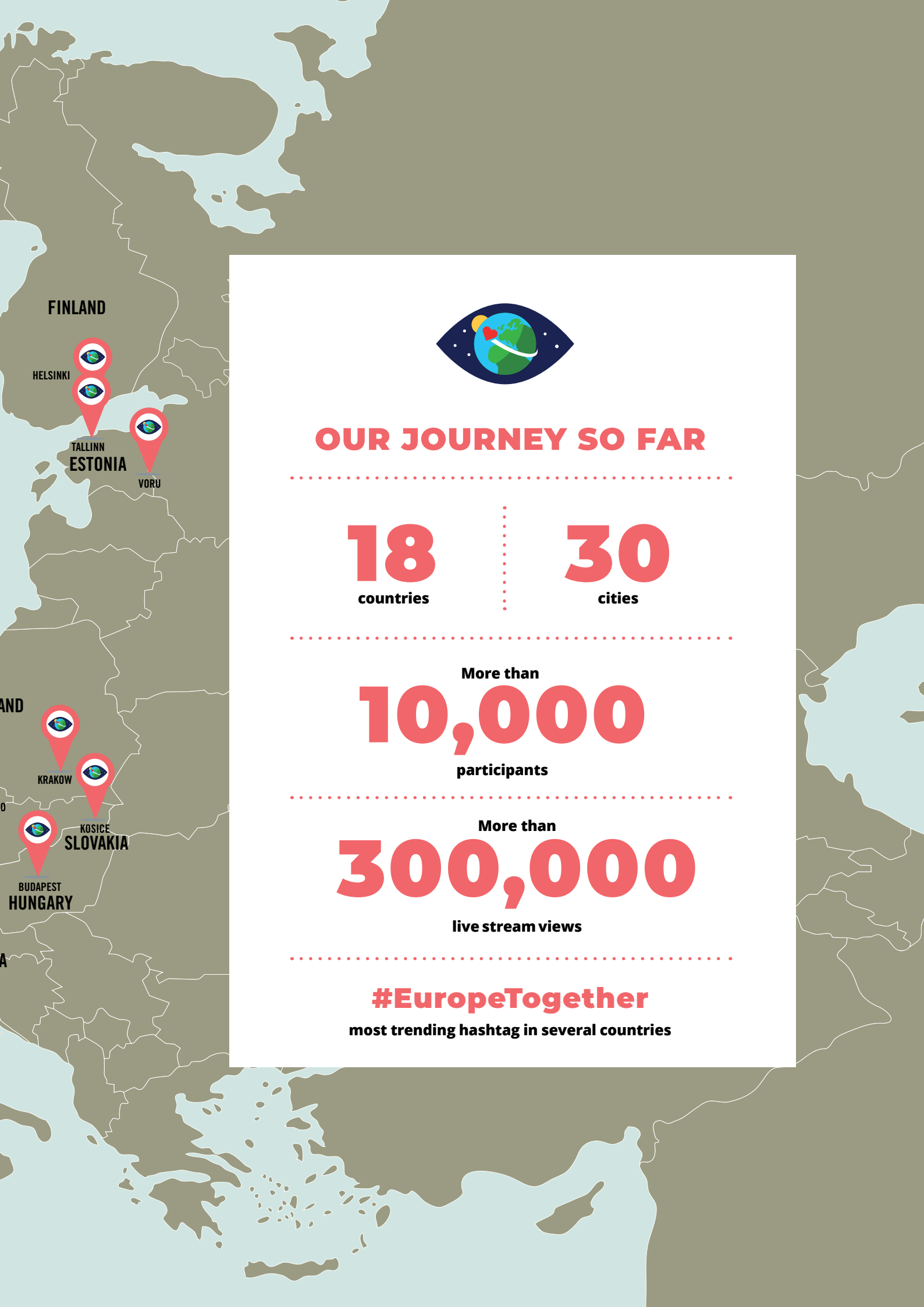

THE FUTURE OF THE EU COHESION POLICY

The need for cohesion funds for a better EU

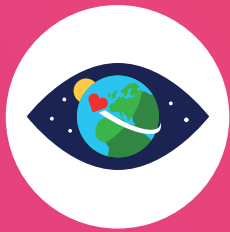
SUSTAINABLE CITIES

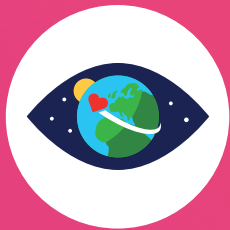
DEMOCRATIC PARTICIPATION IN THE 2019 EUROPEAN PARLIAMENT ELECTIONS

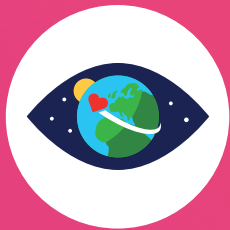
Let's Act Together!

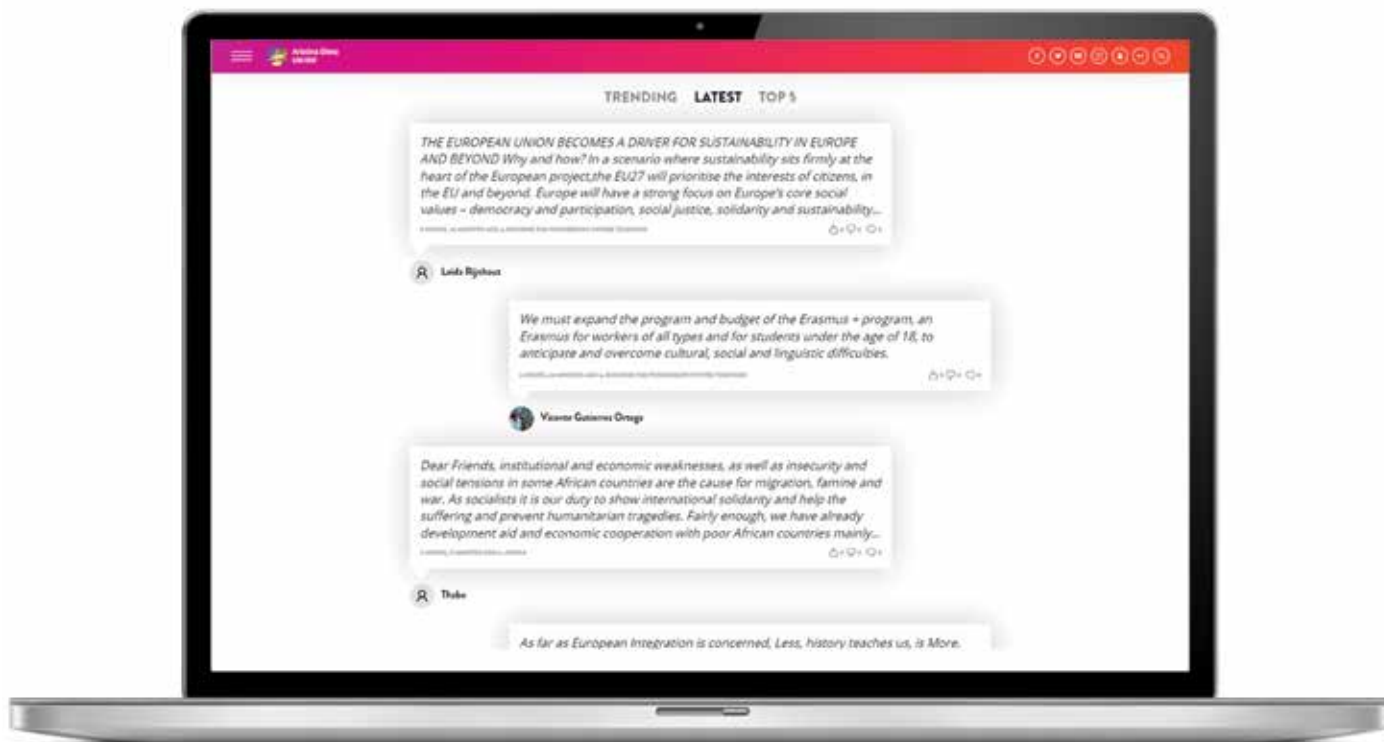


FIGHTING FOR DEMOCRACY!
