## Covid certificates - Juan Fernando López Aguilar MEP, S&D chair of the civil liberties, justice and home affairs committee and rapporteur

Next week, the European Parliament is debating and voting on the proposed Covid-19 certificates that can help restore, but must not hinder, free movement in Europe. By introducing a common certificate as proof of vaccination, proof of a negative Covid test or proof of having recovered from Covid, we want to make it easier for people to travel freely and safely over the next year. For the European Parliament, it is essential that certificates be free-of-charge and equally available to every EU citizen. We must be clear that the certificate will not be a requirement to being able to move freely and must not lead to further restrictions from member states. We also need to reassure people that this is only a temporary measure and that in using these certificates personal information and the right to privacy will be fully protected.

Solutions need to found together and the good faith from the UK government needs to be restored. In ratifying the TCA we are strengthening our hand as its terms includes unambiguous measures, such as restricting market access, to enforce what both sides have agreed."

The pandemic is exacerbating the situation even further, making European and national public intervention more urgent than ever. Childhood poverty in not just about countless individual tragedies, it also inflicts long-term damage on our societies as it increases the likelihood of experiencing unemployment, poverty, homelessness and drug abuse later in life. That is why, since 2014, we have been campaigning for a new integrated approach to tackle to multidimensional aspects of child poverty: the European Child Guarantee. EU governments must ensure decent housing and adequate nutrition, as well as free, quality education, childcare and healthcare for all children in need. The S&D Group welcomes the long-awaited Commission proposal, as the European Child Guarantee becomes a key structural reform and it should be considered as an investment in the stability and prosperity of the European Union, necessary for preserving the EU's growth potential. Investment in young children is the most important means of improving economic and social welfare. ## Russia, the case of Alexei Navalny, military build-up on Ukraine's border and Russian attacks in the Czech Republic - Tonino Picula, S&D coordinator in AFET committee

Our Group is extremely worried by the Russian military build-up on Ukraine's border and in annexed Crimea. Whatever Russia's intentions are, it must have no doubt that the EU and its transatlantic partners remain unwaveringly committed to the sovereignty and territorial integrity of Ukraine, and will not allow Moscow's deliberate destabilisation of neighbouring Ukraine for domestic reasons. We will also call for a strong EU reaction and solidarity over the Russian attack in the Czech Republic in 2014. Last but not least our attention is focused on Alexei Navalny, an imprisoned Russian dissident whose life is in danger. He must urgently be granted medical treatment that he and the international community can trust, and be released. We call for close cooperation with the US administration on these issues.
