# A European Strategy for Hydrogen – Jens Geier, S&D MEP and rapporteur on the European hydrogen strategy

With the report on a European hydrogen strategy, we want to give a strong signal on the importance of renewable hydrogen for Europe's decarbonisation. The report therefore underlines that renewable hydrogen is the only long-term sustainable type of hydrogen, but also acknowledges the transitional role of low-carbon hydrogen. # Recent deaths in the Mediterranean and search and rescue at sea -Birgit Sippel, S&D MEP and spokesperson on civil liberties, justice and home affairs

In the first four months of 2021, more than 600 people have died in the Mediterranean. Every single loss of life at sea is a tragedy. Even more so since rescue was an option and the heart-breaking loss of life is preventable and unacceptable. The EU must wake up and bear its responsibility for the increasing death toll at sea. That is why the S&D Group supported a debate with the Commission and the Council on the recent deaths in the Mediterranean and search and rescue at sea. Instead of deterring migrants and refugees, the EU has to step up its efforts in search and rescue operations and take rescued asylum-seekers to safe European ports. As MEPs we have a responsibility to make sure the Commission and member states uphold international and EU law, like an individual's right to asylum, but we also have a duty as co-legislators on the New Pact on Migration and Asylum to build in genuine EU solidarity on policies like search and rescue, and safe disembarkation to prevent further loss of life.

# Reports on Turkey – S&D MEP Nacho Sánchez Amor, EP standing rapporteur on

The European Parliament is set to debate and vote its annual report on Turkey, which is possibly the toughest EP report ever on the situation in the country. This is just a reflection of the serious and continued backsliding in the areas of the rule of law and human rights in Turkey in the last 2 years, and the unprecedented scale of the crackdown on democratic opposition and any critical voices. The report sends clear messages to both Turkey and the other EU institutions and member states: without urgent progress in the human rights and the rule of law situation in Turkey, there can be no improvement in EU-Turkey relations. We welcome the recent de-escalation and the change of narrative towards the EU from Turkish authorities but now we need facts that will prove their commitment to these words. The European Parliament will not support any EU policy towards Turkey that forsake human rights and the rule of law. This report also renews our firm commitment to keep supporting Turkish civil society, who still largely looks towards the EU with hope.

## Data Protection Adequacy – Juan Fernando López Aguilar, S&D chair of the committee on civil liberties, justice and home affairs

On Thursday, there will be an important joint debate taking place on data protection adequacy. Firstly, in the context of the invalidity of the US-EU Privacy Shield through the Schrems II case, the S&D Group will be leading the Parliament's calls for the Commission to ensure compliance with GDPR and every aspect of the EU court rulings when it negotiates any new personal data transfer agreements with the US. When it comes to the UK adequacy decision, S&D MEPs will be highlighting our concerns around the UK's laws and practices when it comes to data protection. We expect widespread support from MEPs for our report calling for the Commission to modify its decision and for our demand that there is an action plan in place to allow for the eventual granting of the adequacy decision.
