



STATEMENT BY THE PRESIDENT OF THE COMMISSION ON WEDNESDAY 15 SEPTEMBER State of the Union

Pedro Margues, S&D MEP and vice-president for foreign policy

Following the takeover of the Afghanistan by the Taliban, we are extremely concerned about the humanitarian catastrophe that is unfolding. Our message must one of solidarity, and not of fearmongering. New procedures including safe corridors must be found urgently to continue evacuations through the UNHCR for all who wish to leave Afghanistan and most notably for those most at risk, including through the reopening of Kabul airport and land borders. Support for relief and resettlement in neighbouring countries is necessary but is not a replacement for Europe to shoulder its responsibility in welcoming refugees at risk of prosecution or killing. Our absolute priority must also be engaging with international donors to set up distribution channels for humanitarian aid. The Taliban allowing humanitarian workers to work freely will be the first test for them. Realistic conditions must be assessed for engagement with the country including the resumption of development aid disbursed directly to civil society organisations on the ground. But there must be a strong human rights clause - and particularly respect for women's rights - to be attached to EU financial assistance for the country. The international community must demand concrete commitments regarding the safety and well-being of women and girls in talks with the Taliban, to protect the gains that were made for Afghan women in the last 20 years. We also support the HR/VP to use Afghanistan as a breakthrough moment for asserting the path towards EU Strategic Autonomy. The Afghanistan situation has illustrated that the EU needs to reinforce both its autonomy over decisions and its autonomy over action

It is so easy - with one click on your smartphone you can order food, a car to take you places or a cleaner to tidy your home. During the pandemic we have grown even more accustomed to these nice conveniences of modern life. But how do they affect the lives of the people behind the app? Currently, platform workers are considered as self-employed. As a consequence they are only too often denied paid leave, social security, decent working conditions. We want to change the game of the gig economy. Platform workers must be considered as employees as a general presumption and every time they claim to be in an employment relation, entailing full social and worker's rights. If the platform companies disagree, it is up to them to prove that no employment relationship exists with the worker and they are dealing with genuine self-employed. Already today one in ten Europeans has performed platform work. We call on the Commission to urgently propose EU laws to better protect platform workers.

Once again the European Parliament must hold an important debate on Poland, because unfortunately the Law and Justice government is escalating the fight against the rule of law and democracy on so many fronts. They now want to adopt the so-called Lex-TVN bill, which clearly goes against the very essence of the public right to unbiased information and freedom of speech. They say the bill seeks to prevent potential media acquisitions by non-EU countries, but in reality, they want to target independent and critical media such as TVN. Ahead of the expected ruling from the PiS controlled Constitutional Tribunal, we also need to remind the Polish government that by joining the EU, Poland accepted the primacy of the EU law. This means that the ECJ rulings must be fully respected and we will not accept any kind of pressure against the independence of Polish judges, including when they are applying EU law and judgments from the European Court of Justice

Unfortunately, recent years have shown that Russia is choosing confrontation over cooperation. Blatant violations of international law that threaten security and stability in Europe and their ever more aggressive disinformation campaigns are only some of the most egregious examples. What we now need is a forward-looking EU policy towards Russia, that will move the EU from a reactive to a more strategic approach. This requires unity of course. Continued support for Russia's civil society is needed more than ever, in particular in the light of the crackdown on Russian civil society and opposition ahead of this month's Duma elections. Selective engagement on global challenges such as climate change, environment or health, or on conflict prevention and resolution should be used to firmly anchor Russia in the multilateral system.
