We need Europe to be more effective in coordinating anti-terrorism policies and we also need a common and coordinated response to the refugee crisis. Europe must strengthen its solidarity by concrete commitments. The terrorist attacks call for more commitment from Europe, more solidarity. Without solidarity, there will be no viable solution on the duration. Europe and its member states must act as soon as possible against the radicalization, because the prevention is strategic. We need a more committed Europe to strengthen cooperation among national intelligence services and to reinforce control of our external borders while safeguarding Schengen, one of the most powerful symbols of EU integration. We need a more committed Europe through an effective PNR mechanism that goes hand in hand with right to data protection. We need a more committed Europe in allowing member states the flexibility to have extra spending on counter-terrorism exempted from EU fiscal rules, as proposed by president Juncker. And what is certain is that we need a more committed Europe in the fight against Daesh, cutting their funding channels.

The Border package has the aim to introduce common high standards of border management. The package will introduce more robust rules to keep a tighter control on who enters the EU and to further prevent unauthorised entry as well as preventing people from entering outside regular border crossing points. While our Group welcomes a more joined-up approach to external border management, parliamentary oversight and a robust fundamental rights compliance system is a key complementary instrument which should go hand in hand with this new package. However, the revision of the Schengen Border Code submitting all European Union citizens to systematic checks requires a serious and careful deliberation as it does not only raise a doubt of technical feasibility but also serious questions as to the fundamental rights of our citizens.

The right to free movement of citizens and workers is a core European value and a fundamental right of European citizens. It is also a pillar of the success of the European Union's single market. However, the lack of ambition and dedication on the part of the European Commission and some member states to defend the European social model is resulting in the spreading of social dumping, unfair competition and market distortions. We, the Social Democrats strongly deplore the European Commission's decision to postpone the adoption of the Labour Mobility Package which was meant to strengthen social rights in Europe. Among the proposals was the revision of the directive on the posting of workers in Europe. This comes not only at the expense of workers, irrespective of whether they are mobile, migrant or domestic workers, who are deprived of basic social and labour rights. It is also at the expense of companies, which abide by the rules. It is not acceptable that scrupulous companies increase their profit margins by exploiting workers as cheap labour and depriving them of their labour and social rights. We are firmly committed to fight social dumping, discrimination and the exploitation of workers, especially those who are posted. Therefore we must ensure that the principle of 'equal pay for equal work' expands across national borders.

The S&D Group has repeatedly expressed its concerns regarding the constitutional, legal and political developments in Hungary for years. These developments clearly undermined the principles of the rule of law, democracy and fundamental rights in the country over the past years. The reluctance of the European Union to react to such threats and breaches of its own founding values contributed to the occurrence of similar developments in other European countries and cracks those very same foundations themselves. The European Commission, as Guardian of the Treaties, declared time after time its readiness to use all the means at its disposal to ensure that the Hungarian government fulfils its obligation under the Treaties and the EU law. Last week, however, the Commission fell short of its promise and did not acknowledge the systematic nature of these threats and breaches in Hungary. Our political and moral imperative is to make clear that such non-compliance and disrespect of the fundamental values of the European Union is unacceptable and we will do what is necessary to protect and fight for them.

The S&D Group underlines that today's huge humanitarian challenges require a more inclusive, diverse and truly global humanitarian system, to be strengthened at the World Humanitarian Summit (WHS) which will be held in Istanbul on the 23-24 May. The Group recognises the diversity in today's humanitarian response system and the complementary roles of all actors and calls on the EU to promote a 'Global Consensus on Humanitarian Action' that reaffirms the principles of humanitarian aid and the obligations and entitlements under international humanitarian law (IHL). The Group emphasises that all EU humanitarian actions should be guided by the humanitarian principles, including solidarity, responsibility and accountability, and should be designed to ensure that vulnerable people are protected, both physically and psychologically.

The report on corporate tax avoidance aims to make multinational firms pay the billions and billions of pounds lost every year to tax evasion and aggressive tax avoidance. People across Europe are rightly furious that they face higher taxes or cuts to public services as a result of multinational companies with clever advisers reducing their own tax bill to almost nothing. This report sets out a clear plan for action at EU level that will stop these kinds of practices once and for all. The report also suggests mandatory, public country-by-country reporting, meaning that all companies that

operate across borders must publicly report on where they make their profits and where they pay their taxes. As part of efforts to bring more people forward as whistle-blowers – as happened in the lux leaks scandal – the report introduces better protection for those who report misconduct or illegal activity to the authorities or the public. By introducing laws at EU level, we can prevent companies jumping across borders to reduce their corporate tax bill to almost zero.

The resolution adopted by the ECON committee on 1st of December takes stock of the recent Commission's proposals to strengthen the Economic and Monetary Union, following up on the proposals of the five Presidents report. While acknowledging that the proposals represent a first step in the right direction, the resolution asks for additional efforts to be made to successfully address the weak points of the current institutional framework of the Euro area. In fact, the package presented by the Commission does not leave enough room for parliamentary scrutiny at the European level of the implementation of the macroeconomic adjustment programme, which we deem of key importance to ensure the democratic accountability of the decisions taken as part of the EMU. Therefore, we aim to stress the need of a regular parliamentary oversight of the process, through a deeper involvement of the European Parliament in the European Semester, to ensure a higher degree of democratic accountability of the decisions taken and, as a consequence, of citizens' ownership of Euro area governance.
